A Message From the Superintendent

Dear Akron School Community,

With the help of our entire school community, Akron students continue to be recognized for outstanding accomplishments in the classroom, on the athletic fields, in the arts and in the community. We all can be proud of the fact that our school was ranked #12 of 97 districts in Western New York and #43 of 432 Upstate districts. While we are happy with our progress, we continue to strive to provide our students with top quality education that will allow them to be successful in college and careers. I hope that the content of this newsletter provides you with the information you need to make an informed decision at the polls on May 19th.

This year's budget was particularly challenging due to the fact that Governor Cuomo withheld the annual budget runs that normally come out in January, until the end of March. Thanks to the advocacy efforts of many people in our community, the Gap Elimination Adjustment (GEA) that has reduced our NYS Aid by \$9,378,821 over the past few years was significantly decreased. While we are still receiving less than we did in 2008-2009, we will be able to add back some programs and services for our students.

As we begin the slow recovery process the Board of Education has been very thoughtful in budget development, trying to restore programs and services at a sustainable rate while reducing our use of reserves to balance the budget, with sensitivity to our taxpayers. The Board has proposed a budget with a 0.95% increase in the tax levy.

I encourage District residents to attend our Budget Hearing on Tuesday, May 12th at 7:00PM in the auditorium and to vote on the budget May 19th from 12:00 to 9:00 PM in High School Gym 3. Please feel free to call me with any questions you may have. I can be reached at (716)542-5006.

Akron Elementary Building Achievements 2014-15



- Akron Elementary improves its elementary school ranking by 25 spots for both public and private schools in WNY.
- Students had the opportunity to participate in three afterschool enrichment programs: Science Nature Ed-Ventures, Culture Kids Spanish Foreign Language Program and Bricks 4 Kids (Lego building). More than 400 students participated in at least one of these PTA sponsored programs.
- Kindergarten students travel to the Erie County Fairgrounds to participate in "Farm 2 Table," a program that supports our curriculum with handson activities about agriculture and how food from the farm ends up on their table.

- Showing care and compassion, Akron
 Elementary's entire staff participated in the ALS
 Ice Bucket Challenge. The school raised more
 than \$700 towards this worthy cause, adding
 to the \$25,000 raised in 2013-14 in honor of
 Physical Education teacher, Linda Kwasniak.
- More than 80% of parents participated in Parent-Teacher Conferences. The home and school relationship is one of the most important indicators of student success.
- Service Learning opportunities included the annual holiday canned food drive that brought in over 2,000 donated items to support the Akron Food Pantry. Second and third grade classes visited residents at The Cloisters bringing holiday cheer, while the Art Department continues to partner with the Akron PTA to display student artwork throughout the community. Elementary "jumpers" in 3rd, 4th and 5th grade raised over \$2,300 for the American Heart Association's annual Jump Rope for Heart campaign.
- Exercises that simulated a disability were experienced by first, second and third graders during DisAbility Awareness Days. Fourth grade students learned about disability etiquette from the curator of the Museum of disABILITY and Mrs. Teena Fitzroy returned to speak with fifth

- graders about the "Junk in her Trunk" and how she successfully lives with her disability.
- Pizza Hut's "Book It" program and the Darien Lake "Read To Ride" program help to encourage students to meet the monthly reading goals and promote a love for reading. More than 350 students are expected to be rewarded with a free pass to Darien Lake this summer.
- A direct result of the tremendous work done
 in the early stages of a student's music career,
 Akron is designated a "Best Communities for
 Music Education" by NAMM for the third
 year. Approximately 70% of students in grades
 3-5 participate in chorus, band or orchestra.
 November's weather woes cancelled the
 elementary All-County Music Festival auditions,
 but many are expected to participate next school
 year.
- Akron continues to rank in the Top 10 for New York State for the PTA's efforts in collecting Box Tops for Education, redemption coupons found on hundreds of grocery and general merchandise products. The subsequent funding enhances student programming opportunities including a new book for every student distributed at the annual June Reading Carnival.

Akron Middle School Building Achievements 2014-15

- Akron Middle School improved its Business First ranking for the third year in a row! Akron Middle School is now ranked 18th of all public Middle Schools in WNY and 45th of all public and private Middle Schools.
- Akron Middle School educators participated in a year-long Strengthening Teacher and Leader Effectiveness (STLE) professional development program, sharing ideas to improve instruction and increase their capacity to improve the academic achievement of their students.
- Special area subject students and teachers participated in quarterly "Reading for Meaning" activities to help improve literacy and meet the demands of Common Core assessments.
- Among the best student musicians in Erie County: Micah Suckow – Percussion, Riley Polkowski – Euphonium and Shannon Roberts – Viola, were selected to All-County ensembles.
- Celebrating March "Music in our Schools Month," the Music Department put on the orchestra's "Music & Munchies" event and the chorus, concert and jazz band's Cabaret Concert performances.
- Over \$2,000 was raised for the annual United Way Campaign.
- 58 Middle School students participated in the March production of Shrek the Musical.
- Akron Schools was designated a "Best Communities for Music Education" for the third year in a row!

- Middle School Government hosted a Halloween Fun Night, Lasertron and Bowling Fun Night trips, and a Hawaiian Luau Fun Night. They raised funds for their activities by collecting recyclable cans and bottles and holding a Tiger Gear clothing sale. Students also helped with the Homecoming football game food drive.

Fiscal Accountability Summary

Commissioner's Regulations require that certain expenditure ratios for general-education and special-education students be reported and compared with ratios for similar districts and all public schools. The required ratios forth is district are reported below.

The numbers used to compute the statistics on this page were collected on the State Aid Form A, the State Aid Form F, the School District Annual Financial Report (ST-3), and from the Student Information Repository System (SIRS). These data are from the 2012-13 school year.

Instructional Expenditures for General Education are K-12 expenditures for classroom instruction (excluding Special Education) plus a proration of building level administrative and instructional support expenditures. These expenditures include amounts for instruction of students with disabilities in a general-education setting. District expenditures, such as transportation, debt service and district-wide administration are not included.

The pupil count for General Education is K-12 average daily membership plus K-12 pupils for whom the district pays tuition to another school district. This number represents all pupils, including those classified as having disabilities and those not classified, excluding only students with disabilities placed out of district. Pupils resident in the district but attending a charter school are included. For districts in which a county jail is located, this number includes incarcerated youth to whom the district must provide an education program.

Instructional Expenditures for Special Education are K-12 expenditures for students with disabilities (including summer special education expenditures) plus a proration of building-level administrative and instructional support expenditures. District expenditures, such as transportation, debt service and district-wide administration are not included.

The pupil count for Special Education is a count of K-12 students with disabilities for the 2012-13 school year plus students for whom the district receives tuition from another district plus students for whom the district pays tuition to another district. Students attending the State schools at Rome and Batavia, private placements and out-of-state placements are included.

Instructional Expenditures Per Pupil is the simple arithmetic ratio of Instructional Expenditures to Pupils. The total cost of instruction for students with disabilities may include both general- and special-education expenditures. Special-education services provided in the general-education class-room may benefit students not classified as having disabilities.

Total Expenditures Per Pupil is the simple arithmetic ratio of Total Expenditures to Pupils. Total Expenditures include district expenditures for class-room instruction, as well as expenditures for transportation, debt service, community service and district-wide administration that are not included in the Instructional Expenditure values for General Education and Special Education. As such, the sum of General Education and Special Education Instructional Expenditures does not equal the Total Expenditures.

Information about Students with Disabilities (2013-14)

Commissioner's Regulations require reporting students with disabilities by the percent of time they are in general education classrooms and the classification rate of students with disabilities. These data are to be compared with percentages for similar districts and all public schools. The required percentages for this district are reported below.

The source data for the statistics in this table were reported through the Student Information Repository System(SIRS) and verified in Verification Report 5. The counts are numbers of students reported in the least restrictive environment categories for school-age programs (ages 6-21) on BEDS Day, which is the first Wednesday of the reporting year. The percentages represent the amount of time students with disabilities are in general-education classrooms, regardless of the amount and cost of special-education services they receive. Rounding of percentage values may cause them to sum to a number slightly different from 100%.



The denominator includes all school-age students who reside in the district. In the case of parentally placed students in nonpublic schools, it includes the number of students who attend the nonpublic schools located in the school district. Source data are drawn from the SIRS and from the Basic Education Data System (BEDS).

STAR Program Information


The New York State School Tax Relief Program (STAR) provides New York homeowners with partial exemptions from school property taxes. If you earn less than \$500,000 and own and live in your home, you are probably eligible for the STAR exemption.

Basic STAR is available for owner-occupied, primary residences where the owners' total income is less than \$500,000. Basic STAR works by exempting the first \$30,000 of the full value of a home from school taxes.

Enhanced STAR provides an increased benefit for the primary residences of senior citizens (age 65 and older) with qualifying incomes. For qualifying seniors, Enhanced STAR exempts the first \$65,300 of the full value of their home from school taxes. For the 2015-16 school year, senior citizens applying for the Enhanced STAR exemption must demonstrate that the combined income of all of the owners of the property was no greater than \$83,300 in 2013.

Beginning with the 2011-12 school tax bills, the savings resulting from the Basic or Enhanced STAR exemptions are limited to a 2% increase over the prior year.

Contingent Budget Spending

Contingency budget estimates are based on Section 2023 of the Education Law. A contingent budget for Akron CSD for 2015-16 is anticipated to result in a decrease of approximately \$152,200 from the original budget of \$29,101,419.

Under a contingency budget, state law allows a school district to operate the regular instructional program, preserve the health and safety of students and staff, and protect the district's property. Districts are prohibited from spending money on items such as new equipment or nonessential maintenance projects. In addition, a district would be required to charge for public use of their facilities, except when there is no cost to the district.
